**APPLICATION FOR LIFE MEMBERSHIP**

**ARTICLE II of the By-Law**

**Section 1. QUALIFICATION FOR MEMBERSHIP – Any person of good moral character who subscribes to the purposes and objectives of the Association may become a member upon compliance with the requirements set by the Board of Trustees.**

**Section 3. CORPORATE MEMBERS – Any person who is eighteen (18) years of age or over, who professes the Christian and/or evinces a desire to join the search for Christian unity or non- confessional understanding regardless of church affiliation, and who has complied with the requirements prescribed by the Board of Trustees, may become a corporate member upon payment of the annual membership dues to be fixed by the Board of Trustees. Only corporate members have the right to vote and be voted upon at the annual or special corporate meeting of processing faiths other than Christian, provided that their number shall not exceed twenty (20%) of the total corporate membership of the Association.**

**Corporate members may be life, sustaining, contributing or regular depending upon payment of their basic annual fee as determined by the Board of Trustees.**

**ARTICLE I, Section 2 – PURPOSE – The enduring purposes of the Association shall be:**

- a) **To develop well-balanced Christian personality, mission in life and usefulness of individuals, as well as to promote unity among Christians and understanding among peoples of all faiths, to the end that the Brotherhoods of Man under the Fatherhood of God may be fostered in an atmosphere of mutual respect and tolerance; and**
- b) **To promote on equal basis the physical, mental, social, and spiritual welfare of the youth and to emphasize reverence for God, social discipline, responsibility for the common good, respect for human dignity and the observance of the Golden Rule.**
